

# Attention 2021 PREMA Irrigators

## 2021 Load Management Program Information

- The Load Management program is limited to those services that can receive the TWACS signal.
- If you are signing up as the landowner, please make sure that your operator or tenant is aware of the program.
- When you sign up for Load Management, PREMA needs the following information: operator or tenant and meter number or account number.
- Irrigators with more than three pivots will have pivots split into two groups.
- The Everyday Rate Group will normally be the last group to be controlled when PREMA is in active control status.
- New signups (pivot without load control switch) will be limited to the first 50 to sign up.

Sign up is **required** again this year for the 2021 Load Management Program. ### Tampering

If you are the owner or operator of an irrigation service on which a load control switch is installed, keep in mind you are responsible for making sure no one tampers with the load control switch.

**The load control switches are operated through the TWACS system with the capability of two-way communication to verify that the switch is operable.**

#### FULSERVICE RATE
